## Simple Guidelines for Paws Crossed Day Event

1. Organization must provide 'Certificate of Insurance' naming Paws Crossed Animal Rescue Inc. as an additional insured, including the address, 100 Warehouse Lane South, Elmsford, NY 10523.
2. Organization is required to bring all equipment needed, including tables, chairs, crates etc.  
... as well as a pop-up tent. Paws Crossed only provides a 10x10 space (or a parking space for a food truck)
1. Organization's exhibit must be manned by the organization during the event at all times.
2. Organization is responsible for maintaining its area during the event and for cleaning up its area prior to departure.
3. If the organization brings any animals to the event, the organization is solely responsible for its animals and must adhere to the following conditions:
  - \* Provide proof of current vaccinations including rabies
  - \* No more than three (3) dogs may be brought on the grounds at one time
  - \* Dogs must be on leash at all times or crated if no handler is available
  - \* Dog handlers must be 18 years of age
  - \* Retractable leashes are prohibited
  - \* Because of the nature of this event, it will be too stressful for our feline companions, so unfortunately, we will not be allowing cats.
4. Paws Crossed is responsible for the success of this event and reserves the right to remove any individual, group of individuals or organization from the event at any time.
5. If any animal sponsored by the organization is adopted as a result of the organization's participation in this event, the organization is solely responsible for the adoption including any effects of a failed adoption (i.e. Return of the animal).
6. Please arrive at the event as early as possible. Due to limited parking, participants need to arrive for exhibit set up between 9:00am and 11:00 am. By 11am all vehicles MUST be removed from area and moved to designated parking areas. Vehicles will be allowed back at the conclusion of the event, 4.00PM.
7. Any photo, video or audio recording taken at the event is the property of Paws Crossed Animal Rescue Inc. and can be used by Paws Crossed for advertising and promotional purposes.
